

## NP4CLE Veterans Day Tribute

### Official Rules

#### No Purchase or Text Message Necessary to Enter or Win.

**1. Eligibility:** The NP4CLE Veterans Day Tribute (“Sweepstakes”) is open to legal residents of Ohio. Only living veterans are eligible to win. Employees, officers, directors, agents, and representatives of Nurenberg, Paris, Heller & McCarthy (“Sponsor”), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies (hereafter collectively, the “Released Parties”), and each such individual’s immediate family members (mother, father, sister, brother, child, husband, wife, and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to win. Void outside Ohio, and where prohibited by law. All applicable federal, state, and local laws apply.

**2. Promotion Period:** Nominations begin at 10:00:00 AM Eastern Time (“ET”) on 10/18/2019. The nomination period ends at 11:59:59 PM MT on 11/18/2019 (“Promotion Period”).

**3. How to Nominate a Veteran:** During the Promotion Period, nominate a veteran by:

Nominations must be received by 11:59:59 PM ET on 11/18/2019 to be eligible. For the purposes of this Sweepstakes, a day is understood to begin at 12:00:00 AM ET and end at 11:59:59 PM ET the same day. Limit one (1) nomination per veteran. All nominations will be reviewed by Nurenberg, Paris, Heller & McCarthy prior to publishing. Submitting inappropriate photos or false information will result in automatic disqualification. Released Parties are not responsible for incomplete, late, garbled, lost, illegible, delayed, misdirected, or stolen entries, purchases, or text messages, failures or malfunctions of phones (including wireless phones/handsets), phone lines, cellular equipment towers, telephone systems, lost nominations or votes, text messages, or transmissions, interrupted or unavailable network, server, wireless service provider, or other connections, miscommunications, failed computer hardware or software or technical failures, garbled, misrouted, scrambled transmissions, printing, typographical, or other errors in these Official Rules, in any Sweepstakes-related advertisements, or other materials, or other errors or problems of any kind whether computer, network, cellular, human, electronic, or otherwise relating to or in connection with this Sweepstakes, including, without limitation, any errors or problems which may occur in connection with the administration of the Sweepstakes, the processing of entries or text messages, or in the announcement of the prize. Winner will be deemed the veteran named on the applicable nomination form. Proof (to Sponsor's satisfaction) of identity and military service may be required by Sponsor. The Released Parties are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's e-mail accounts to receive e-mail messages. The Released Parties are not responsible for false, incorrect, changed, incomplete or illegible contact information.

**5. Six (6) Prizes:** The winners will receive \$500 in cash. Other than the details of the prize outlined here, Released Parties have no additional obligations or commitments to the winners in connection with this Sweepstakes. All prize details are at Sponsor's sole discretion.

**6. Miscellaneous:** No transfer, assignment, cash redemption, or substitution of prize (or portion thereof) except by Sponsor, who reserves the right to substitute a prize(s) with one of comparable or greater value (except as otherwise provided above), at its sole discretion. Winners will be required to execute and return an Affidavit of Eligibility, Liability Release, and (where legal) Publicity Release and any other documents required by Sponsor within five (5) days of date of notification. Non-compliance with the foregoing, with these Official Rules, or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner. Entrants agree, by entering, that 1) Sponsor and its designees may use (unless prohibited by law), entrant's name, city and state of residence, photograph, any recording (voice, film, or video), and/or likeness for advertising, trade, and/or any other purposes in any media now or hereafter known throughout the world in perpetuity, without further compensation, permission, or notification; 2) Sponsor reserves the right to conduct a background check and entry in the Sweepstakes constitutes entrant's permission for Sponsor to conduct such background check, provided that, to the extent additional authorization is necessary under law, entrants shall authorize such check. Sponsor reserves the right (at its sole discretion) to disqualify any entrant based on the results of the background check or failure of the entrant to properly authorize such check; and 3) the Released Parties shall have no liability and will be held harmless by entrant for any claim, action, liability, loss, injury, or damage to entrant, including, without limitation, personal injury or death, or damage to personal or real property, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use, or misuse of the prize and any travel or travel-related activity thereto (including, but not limited to, attendance at the game) or participation in this Sweepstakes. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, or consequential damages, or any other damages, including attorneys' fees, other than entrant's actual out-of-pocket expenses (e.g., costs associated with participating in this Sweepstakes), and entrant further waives all rights to have damages multiplied or increased.
